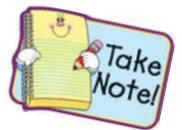

HOA Quarterly Dues



Payable on the first day of the quarter (Jan. 1, April 1, July 1, & Oct. 1). 2026 quarterly dues are \$531.34. Dues are delinquent and will be assessed a late fee if not received by the 15th of the first month of the quarter. The Fountains is not set up for an automatic draw. Each quarter, an invoice must be generated from the portal to pay online. Members who want to pay through the Commerce Bank portal **MUST EMAIL THEIR REQUEST TO AREA EACH TIME**, as the system doesn't automatically generate invoices. We are not collecting your bank account information. Once in the portal, you will supply Commerce Bank with your contact information and bank account information, and the funds will be withdrawn from your account and transferred to the Fountains account the day you click on payment.

THE FOUNTAINS AT RAINTREE LAKE SNOW REMOVAL POLICY Approved October 2025



SNOW REMOVAL

Snow removal will be done when the total average accumulation is **3 inches or greater**, and the weather forecast indicates that temperatures will not rise sufficiently to melt the snow within 24 hours. The Board will decide this condition.

The snow removal contractor will begin work as soon as reasonably possible after a snow event. (We are not a "priority client".) The Board will inform residents by email that snow removal has been ordered.

Every resident should have a snow shovel on hand, and a small supply of sand, kitty litter, and/or safe ice melt to deal with ice. Remember, there are 176 drives to be cleared in the Fountains, and it may take a while to get to yours.

Each resident's front steps and sidewalk leading to the driveway and a 2'-3' space in front of the garage doors will be hand shoveled. Community mailboxes will be cleared for access. Due to insurance restrictions, no snow will be removed from a resident's driveway if a vehicle is parked in the driveway.

The snow removal contractor will not scrape down to expose the concrete. Please note: Clearing down to a completely snow-free surface cannot be done without risking damage to the driveway. To avoid damage to yards and sprinkler heads, snow will not be removed from the very edges of a driveway. It helps the contractor to have snow sticks marking the edge of your drive, but it is not necessary to do so.

In the past, some residents have chosen not to have the contractor remove snow from their property. If you choose this option, you must mark the end of your driveway with cones, flags, or some device that would indicate to the contractor that you do not want them to remove snow from your property. Opting out of snow removal does not allow you to opt out of any HOA fees.

When there is a severe snowstorm warning, be prepared in advance and try to reschedule any necessary shopping, doctor visits, etc. Please contact neighbors, relatives, or government personnel in the event of an emergency.

ICE ISSUES

NO ice removal will be done by the contractor, and no ice-melt products will be applied to steps, sidewalks, or driveways. Please note: Pre and post-treatments with ice melt products will not be provided, but the resident may opt to do so. Be aware that rock salt and many ice melt products can damage concrete surfaces.

GENERAL COMMENTS

The contractor will not remove snow from city-owned sidewalks or walking paths within the Fountains. The City of Lee's Summit is responsible for snow removal from city streets. However, in order to access residents' driveways for snow removal, the contractor may choose to remove snow from city streets in The Fountains as necessary. The City of Lee's Summit has extensive information about how they respond to a snow event, which can be found on the City's website or through their app called LS Connect.

PLEASE DO NOT FEED THE WILDLIFE!!

In 2024, a mother fox and 6 kits burrowed under a resident's back porch and patio, causing over \$1,000 in damage, not to mention the messes left on the lawn. Before the kits were grown, she had moved on to 2 other nearby homes and caused additional damage to their properties. **WE DO NOT WANT FOXES DENNING HERE!!**



BELOW ARE THE KNOWN CONSEQUENCES OF FEEDING WILD ANIMALS!! PLEASE LET THEM STAY WILD!

The Missouri Department of Conservation (MDC) is reminding everyone to appreciate wildlife from a distance and keep wild animals wild.

"When people feed wild animals, either directly or by leaving out pet food or unsecured garbage, they're encouraging unnatural behaviors that can lead to animals becoming aggressive or dependent," said Bridget Jackson, MDC regional recreational use specialist. "It's essential that wild animals remain wary of humans for their own safety." "The best way to help wildlife is to let wild animals stay wild," added Jackson. "Observing nature is a wonderful part of summertime in Missouri. By keeping our distance and respecting wildlife, we can all play a part in conserving the state's natural heritage."

"Human interference, even with good intentions, can often do more harm than good," said Russell Duckworth, MDC protection regional supervisor.

You should not feed foxes in Missouri, as it can cause them to become dependent, habituated to humans, and at a higher risk of disease and conflict. Feeding wildlife can lead to dangerous situations for both the animals and people, including increased conflict with pets, cars, and property damage, as well as the potential spread of diseases.

Why feeding foxes is harmful

- Habituation: Foxes lose their natural fear of humans, which can make them bolder and more likely to approach people, pets, and vehicles.
- Conflict: Habituated foxes may cause property damage, become a nuisance, and pose a risk to pets.
- Disease transmission: Feeding concentrates wildlife, which can increase the risk of spreading diseases to other animals and to people.
- Dependency: Foxes can become dependent on handouts and lose their ability to hunt and forage for themselves.
- Health issues: Human food can be nutritionally inadequate and harmful to foxes.

You should not feed geese in Missouri, as recommended by the Missouri Department of Conservation (MDC) and other wildlife experts. Feeding geese can lead to negative consequences such as increased aggression, disease susceptibility, and unnatural congregations, while also causing them to lose their natural fear of humans.

Negative effects of feeding geese

- Aggressive behavior: Feeding concentrates geese, making them more aggressive toward people as they expect food.
- Health problems: Handouts are often nutritionally inadequate, especially for growing goslings, and can lead to health issues like "angel wing" deformity, making the birds unable to fly. They can also become more susceptible to diseases like avian botulism and avian cholera.
- Loss of natural instincts: Geese may not migrate when they are dependent on human-provided food.
- Environmental damage: Large numbers of geese in one area can lead to property damage and water pollution from excessive droppings.



80/20 HUD'S AGING SURVEY RESULTS

- The Fountains at Raintree Lake is required to survey residents annually to be legally listed as 55+ housing. The community must meet three qualifications:
- 80% of the units/homes must have at least one (1) resident aged 55 or older (80/20 rule).
 - The community must create, publish, and follow policies that show its intent to house residents age 55 and older.
 - The community must follow HUD's age verification rules. This can mean enacting procedures to verify a resident's age.

In October 2025, residents were mailed a survey to complete and return to Area Real Estate, indicating compliance with this requirement. The results of that survey: 130 (of 176) surveys were returned, and all were 55+ years old.

Officially, that puts our compliance at 74%.

GARBAGE BINS REMINDER



The Fountains HOA only provides weekly TRASH pickup with your dues. Residents who wish to have recycling or lawn waste pickup must contract those services individually with GFL. Per RLPOA regulations, you can place your bins out after 5:00 p.m. on Sunday evenings for Monday a.m. pickup.

As required by the Covenants, garbage AND recycling must be placed on the curb in covered bins.

NO uncovered blue recycling bins or bagged garbage. Covered bins keep our volunteers from having to chase YOUR garbage down the street.

Using the wheeled bin helps keep our garbage collection costs down because the truck can pick the bin up and dump it without a person having to handle it. **Please try to allow 4 - 5 feet between containers to make it easier for the garbage truck to get the mechanical lever arms around the bins.**

Neighborhood Watch Information

The LSPD Community Interaction

Office reminds us that most reports in our area are a crime of opportunity. Remember to keep garage doors closed and your doors locked. Always remove valuables from your vehicles and keep them locked when parked outside the garage. Don't make our neighborhood attractive to criminals.

Please report any suspicious activity. The LSPD would prefer to investigate and potentially prevent criminal activity. They also keep track of calls to an area and allocate resources where the most calls occur.

If you are planning to be away from home for a period of time, call 816-969-1770 to ask for a house watch. And let your neighbors know that you are away too! Neighbors, please be watchful for each other!

SIDEWALK MAINTENANCE

The sidewalks in front of your home or along a street belong to the City of Lee's Summit, and they are responsible for maintaining them. If there is a City-owned sidewalk that needs repair, you should contact the City's Public Works Department. A simple way to do this is to use the City's app, "LSConnect". You can find the app in your device's store. This app allows you to create a work order with Public Works in just a few easy steps.

Does it work? Yes, a resident recently reported about 14 different locations, and you will recall that the City repaired sidewalks here a couple of weeks ago. Also, the app lets you contact other City departments to report concerns or problems. It also has lots of other information that you might be interested in.

ANY WORK ON THE OUTSIDE OF YOUR HOUSE REQUIRES THE APPROVAL OF BOTH THE FOUNTAINS (FARB) AND RAIN TREE (RARB) ARCHITECTURAL REVIEW BOARDS

- The property in *The Fountains at Raintree* is bound by the Covenants and the Fountains HOA Board.
- It is the responsibility of FARB to ensure that the **traditional appearance** of the neighborhood is maintained and to **pre-approve** any work on the exterior of your home, whether it changes the appearance or not.
- It is the Homeowner's responsibility to seek and receive the ARB's approval before proceeding with any exterior changes/repairs, including painting, deck staining, garage door replacement, window replacement, new roof, concrete lawn edging, pergolas, decks, patios or extensions, etc.
- **DO NOT WAIT UNTIL THE LAST MINUTE TO REQUEST APPROVAL. IT COULD TAKE UP TO ONE MONTH TO GET APPROVAL FROM BOTH ARBs!** *Your approved project application is good for 6 months.*
- **DO NOT START WORK without all approvals in place!** *Potential financial penalties from both HOAs could be levied against the homeowner!*

PROCESS:

- **Request forms are found on the RLPOA website (www.rlpoa.com/resident-information/forms).** (Don't forget to check to see if a City building permit is required.)
- If you are unsure, then contact a FARB member and they will be able to help you get the appropriate form. See contact information below.
- Submit the completed form to a FARB member: include supporting documentation, paint chips, pictures, plans, or drawings. The more information, the better!
- The application will be reviewed by FARB: approved; determined to require further documentation; or denied.
- When approved, a FARB member will deliver it to the RARB for their approval. Raintree will send out a letter with their findings.
- With the signed approval of both ARBs, you may proceed with the project.
- A denied request can be brought before the Fountains Board for consideration.

IMPROVEMENTS: That still needs Approval.

- All edging, retaining walls, or flower beds
- Outdoor clotheslines or dryers
- Radio or TV transmitting or receiving antennas except for dishes less than 3 ft in diameter
- Towers
- Exterior lighting, Awnings, Shutters.
- All work that alters the appearance or affects drainage around your house.
- A fence in the backyard must be on concrete and be less than 32 inches high.

IMPROVEMENTS: These are usually Approved.

- Improvements that do not alter the exterior of your home.
- Repairs
- Landscaping plants and ornamentation within the edging around the house, usually 18 inches.

FOUNTAINS ROOFING REPLACEMENT

Our present roofs are all Timberline Weathered Wood. The FARB has researched other colors for the Board and has a list of other possible colors and companies that are acceptable to the Raintree ARB and are found on Raintree's Application for Replacement Roofs. All roof replacements, including color change, must have a Raintree Application and be submitted to the FARB first.

SMOKE ALARMS

The original builder's smoke alarms installed in our homes have an effective life cycle of ten years. Each alarm has an expiration/replacement date on it. If your smoke alarms are ten years old or older, they should be replaced. You may need assistance with the high ceiling-mounted alarms.

REQUIREMENTS FOR INSTALLATION OF SOLAR PANELS

1. Solar panels/equipment shall require a written application and approval by FARB and RLPOA Architectural Review Board prior to installation.
- A. Any solar panels and equipment shall be constructed to appear as an integrated part of the building architecture of the home.
- a) Roof mounted.
 - b) The top surface is flush with roof when possible.
 - c) All accessories will be recessed into home's attic.
 - d) Solar panels should be black with black trim.
- B. Solar panels should be located on the rear or side roof of the home whenever possible.
- C. NO ground level application will be approved.
2. Photo System Application must be submitted to and approved by the City of Lee's Summit prior to installation and a copy of the approval must be submitted to the Raintree Administrative office and The Fountains ARB.
3. It is the homeowner's responsibility to maintain the solar panels for as long as they are displayed on the roof of the home as required by the Declaration of Covenants.

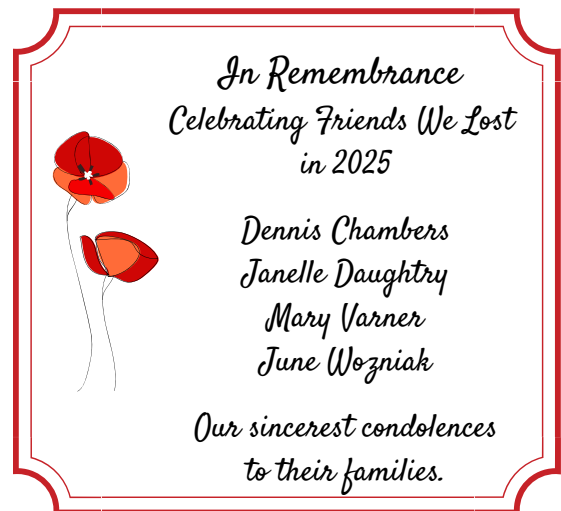
